AFTER THE ACTIVITY BEGINS, ALCOHOLIC BEVERAGES MAY BE BROUGHT ON THE PREMISES BY THE PERSON WHOSE SIGNATURE APPEARS BELOW, **No EXCEPTIONS**. ALCOHOLIC BEVERAGES MUST BE CONFINED TO AN ASSIGNED AREA OF THE PARK OR FACILITY. NO ALCOHOLIC BEVERAGE WILL BE FURNISHED TO MINORS OR PERSONS UNDER THE AGE OF 21.

THE POLICE DEPARTMENT HAS THE AUTHORITY TO STOP ANY ACTIVITY IN ANY CITY PARK OR FACILITY. IF A PROBLEM ARISES, AS A RESULT OF THE ISSUANCE OF THE PERMIT, THE POLICE DEPARTMENT MAY DEEM THE PERMIT INVALID.

THIS PERMIT IS VALID ONLY WHEN AUTHORIZED AND SIGNED BY THE CHIEF OF POLICE OR AN ADMINISTERING OFFICER. PERMIT HOLDER(S) MUST HAVE SAID PERMIT IN POSSESSION WHILE USING THE PARK OR FACILITY AND UPON DEMAND MUST PRODUCE SAID PERMIT FOR OFFICER'S REVIEW. THE PERMIT IS VALID ONLY FOR THE DATE AND TIME SPECIFIED.

THE ALCOHOLIC BEVERAGE PERMIT APPLICATION MUST BE SUBMITTED AT LEAST TWO (2) WEEKS BEFORE THE ACTIVITY TAKES PLACE. IF PERMIT IS NOT SECURED BY THE TIME SPECIFIED, PERMIT MAY BE REJECTED.

I HAVE READ THIS PERMIT AND AGREE TO COMPLY WITH ALL REQUIREMENTS SET FORTH HEREIN. THE UNDERSIGNED UNDERSTANDS THAT THE CITY OF SOLEDAD ISSUES THIS ALCOHOLIC BEVERAGE PERMIT WITH THE UNDERSTANDING THAT THE CITY OF SOLEDAD, ITS EMPLOYEES AND AGENTS WILL NOT BE HELD RESPONSIBLE FOR ANY ACCIDENTS OR INJURIES WHICH MIGHT OCCUR AS A RESULT OF IMBIBING INTOXICATING ALCOHOLIC BEVERAGES DURING THE ABOVE DESCRIBED ACTIVITY.
